

Message from our Co Chairs

2024/25 has been a pivotal year for public health in London, bringing both formidable challenges and exciting opportunities. Through ADPH London, we continue to advocate for our communities at the highest level while strengthening our collaboration with system partners.

The election of Sadiq Khan for a historic third term as Mayor of London in May, with renewed commitment to making London fairer, safer and greener for all, combined with Labour coming to power in July 2024, has brought better alignment between national and regional administrations. However, fixing the NHS being one of the new government's priorities, a new 10-Year plan is being developed with a focus on three main shifts: moving care into the community, focusing on prevention, and modernising services through digital innovation.

This root-and-branch reform—marked by the planned abolition of NHS England—is being framed as the most significant decentralisation of power in NHS history. While its ambition is to empower Integrated Care Boards (ICBs), public health teams, and Health and Wellbeing Boards with greater autonomy, the implications for public health are complex. ICBs are facing a 50% reduction in running costs, to be achieved through streamlining, collaboration, and potential mergers. This creates a challenging financial environment and considerable uncertainty, which directly affects the capacity of our public health teams to deliver on expanding responsibilities. It is important that we are involved in the changes and taking opportunities to influence what the future system looks like.

Yet, within this disruption lies opportunity. Greater autonomy could enable more locally responsive, prevention-focused public health strategies. However, to realise this potential, public health must be adequately resourced and supported with a sustainable workforce. In this evolving landscape, working together as a cohesive public health system - across local government, the NHS, and communities—has never been more vital. It is important that we are involved in the changes and taking opportunities to influence what the future system looks like.

London continues to face deep-rooted health inequalities, exacerbated by economic pressures, housing insecurity, and the cost-of-living crisis. This continues to challenge us and drive us to make a difference and there have been some great examples of local initiatives right across London.

This year also saw the development and launch of the Why We Get Vaccinated campaign, a multi agency behaviour change initiative, co-produced with London communities, to address low vaccination in London, with notable disparities with certain ethnic groups and amongst the vulnerable. The campaign is part of the London Immunisation Strategy and another great example of successful collaboration through ADPH London.

Similarly, we have worked with a broad range of London partners to develop the Million Hearts and Minds Challenge, laying the groundwork to making a step change in heart health across the city, improving CVD outcomes and closing health equity gaps. We look forward to seeing it mobilised next year.

Another highlight of the year was the expansion of our smoking cessation programme through the London Tobacco Alliance, with the successful implementation of the pan-London digital app pilot, made possible by new central government funding. This demonstrates the power of coordinated action and innovation, to address a major cause of preventable death and disease in our capital and bringing the vision of a Smoke Free London by 2030 closer.

Through ADPH London we support the wider public health workforce with regular communications and through our thematic networks and communities of practice. These vibrant networks enable public health professionals and partners to share expertise and drive system-wide improvement. We actively promote thematic Lead roles when available, providing invaluable opportunities for current and aspiring DsPH to develop professionally and progress your careers.

As this report shows, the year has been marked by dedication, collaboration, and impact. Thank you to the ADPH London team, our thematic Leads, all DsPH members, and our partners - including the GLA, OHID London, NHSE, and UKHSA for your continued commitment to improving the health of Londoners.



The Leadership Team consists of a Chair or joint Chairs and up to 3 Vice-Chairs, elected by members on a bi-annual basis. Our next elections are due to take place in December 2026.

A Year in Public Health

Highlights of 2024/25

April 2024

The Health Foundation publishes **Health Inequalities in 2040** report that signals,
without action, the UK's health will continue to
decline, placing increasing demand on health
and social care services and affecting
productivey.

June 2024

The UK experienced a notable summer wave of COVID-19 infections with a 33% rise in cases and 24% increase in hospitalisation, linked to waning immunity, emergence of new FLiRT variants and social mixing during EURO 24

August 2024

Whooping cough cases rise to over 10,000 and UKHSA urges pregnant women to get vaccinated to protect their new born babies.



May 2024

Sadiq Khan secures a record third term in the Mayoral Elections. His campaign centred around a 'safer, fairer and greener capital', with a particular emphasis on health policies.



July 2024

The UK becomes the first country in the world to offer a national vaccination programme using the same vaccine to protect infants and older adults from RSV



September 2024

The Mayor of London launches an ambitious 10-year plan to clean up London's waterways, bringing together companies, government agencies, charities and campaigners to clean up the waterways for the benefit of all.



A Year in Public Health

Highlights of 2024/25

October 2024

A new report by the UCL Institute of Health Equity (IHE), **Structural Racism**, **Ethnicity and Health Inequalities in London**, concludes that racism damages health and wellbeing and drives inequality in London.

London's Why We Get Vaccinated campaign launches, a 3-year, behaviour change campaign co-produced with London's communities and ADPH London in partnership with UKHSA London, London Councils and NHSE London

December 2024

CMO, Prof Sir Michael Whitty's annual report published, this year on Health in Cities. The report outlines a broad range of health opportunities and challenges for city populations.

February 2025

England's updated Public Health Outcomes Framework reveals rising obesity and smoking in early pregnancy, persistent school readiness gaps, and highlighted racism's impact on health inequalities in London.













November 2024

The Tobacco and Vapes Bill, the biggest public health intervention since the ban on smoking in public places in 2007, was introduced to parliament.

The Bill is a key pillar of the Government's Health Mission to help people stay healthier for longer, reduce the number of premature deaths and raise the healthiest generation of children in our history.

January 2025

UKHSA reports a significant increase in cases of tuberculosis in England, although a low incidence country, cases risen from 8.5 per 100k population in 2023 to 9.5 per 100k population in 2024. Largest increase seen in London and West Midlands.

March 2025

Government announces that NHS England will be abolished and brought under 'democratic control'.

The organisation will be brought into the Department of Health, and the move expected to free up money for frontline services.

One year on from the expansion of the Ultra Low Emission Zone to Outer London, new data shows that the ULEZ has substantially reduced harmful emissions leading to all Londoners breathing cleaner air, with more deprived communities seeing even greater benefits.

We bade farewell to Carole Furlong, departing Harrow DPH who is retiring after a long career and welcomed her replacement, Laurence Gibson.


We welcomed back our Public Health Strategist, Joleene from maternity leave.



We support individuals to look after their mental health and wellbeing in a way that works best for them, providing a range of tools, apps and culturally competent resources to help manage sleeplessness, anxiety, stress, low mood and other feelings.



Outcomes for 2024/25

London HIV Prevention Programme



Aims & Objectives

Aim: To reduce the incidence of HIV in the capital

Objectives: To increase the awareness and uptake of the methods effective at preventing HIV to all Londoners and key populations disproportionality affected by HIV



Outcomes for 2024/25



Staffing

Significant staff changes took place, which involved the appointment of the new lead commissioner, a communications commissioning manager, and a senior commissioning officer. (July, Oct, Nov)



Campaigns

- Increased organic, evergreen content on social media, focusing on informative content for our target audiences. Spikes of campaign activity at key moments including:
- Targeted adverts throughout Pride month and over London Fetish Week, delivering over 3.6 million impressions and 1,772 clicks cumulatively
- Multilingual, geotargeted advertising leading up to and over World AIDS Day, resulting in over 2.3 million impressions, and 8000 clicks through to SHL.UK
- Spring campaign promoting HIV testing to key audiences including women and young men with bespoke messaging, and innovations on new platforms including podcast audio advertising, contributing to a record month for self-test orders.



Partnerships

'Significant work has been undertaken to develop and improve partnerships with key stakeholders who interact with the public – including GPs, pharmacies, councils and gyms. This includes providing relevant videos and resources, and communications packs for ongoing use and in particular for national campaigns such as HIV Testing Week.

Branding and Audience Insight Work

Mobilisation of new providers of the communications function - Unlimited Pablo creative agency and the7Stars media buyers. Significant work has been undertaken on a brand refresh, development of an updated communications strategy, and detailed audience insight work.



Impact

- Targeted and relevant campaign activity has driven record numbers of HIV self-testing kits. Orders in Jan-March 2025 (289) have exceeded total orders for both the whole of 2022 and 2023 and are set to pass total orders for 2024 (330) shortly. The programme is on track to exceed 1000 orders in a year for the first time since records began, providing significant cost savings to boroughs and an important service to London residents.
- The inclusion of multilingual adverts and social content has increased accessibility and awareness of HIV prevention options, and successful engagement with this content has laid the foundation for further innovations in this area in the upcoming year.



GBMSM Outreach Programme

- The GBMSM Outreach Programme's pilot to increase uptake of SHL testing kits, (Aug 2023 Sept 2024) issued 687 STI kits, achieving a 98% return rate. This successful pilot service is now linked to the LHPP outreach programme, creating a cohesive network that enhances accessibility and support for GBMSM to engage with the SHL e-service.
- GBMSM outreach team at key community events London Pride, Fetish week, UK Black Pride Bi Pride, Student Pride, Muslim Pride Trans Pride and local borough Pride events. The outreach team also identified and worked across new venues and spaces increasing engagement with GBMSM with intersectional characteristics.
- Procurement the outreach + engagement service 2025/27 was completed and the contract awarded to Metro Charity/GMI partnership. The new service was mobilised and scheduled to commence 1st April 2025

Black Heritage Communities Programme

PHAST Consultancy was commissioned in September 2024 to conduct a rapid needs assessment, the outcomes of which will inform a programme of work scheduled to be commissioned in 2025/26.

The needs assessment undertaken was informed by the following elements:

- Desktop Evidence and Epidemiology Review
- Sector and VCS Engagement
- Resident Engagement

Summary of engagement

- Resident Survey 455 response
- Commissioners survey 30/33 commissioners responded
- HIV/SH providers 11 providers interviewed
- VCS providers (non-HIV/SH) 3 providers interviewed

The final report was delivered on 24 March 2025.



Plans for 2025/26

- Delivery of GBMSM outreach and engagement service, with an increased focus on GBMSM with intersectional characteristics and the introduction of a peer champion model.
- Continue to deliver evergreen content of the DIL campaign throughout 25/26, using key dates/events to increase coverage/reach.
- Rollout of updated branding, including across website, social media, outreach work, and media campaigns (June 2025 onwards)
- Innovations to engage key audiences, including multilingual website, multilingual videos, leaflets and posters, addition of photography including key target audiences, exploration of building of ambassador programme
- Publication and dissemination of report on needs and engagement with HIV services for Black Heritage communities in London. (June 2025)
- Design and mobilisation of the Black heritage HIV prevention and outreach programme inc. recruitment of programme lead, strategy development, key relationship building, and implementation of culturally appropriate interventions across London.







Announcement

Government announced additional new grant funding to support current smokers to quit smoking

Amounts to £10m p.a. across London.

Funding guidance supported:

- Jointly funding activity across a wider geographical area (eg London)
- Building capacity within the system to support more people to quit smoking
- Funding digital or remote support programmes

Proposal

Proposal for DsPH to contribute 3% of additional grant to fund integrated digital smoking cessation pilot for London.

- Complements existing services to add capacity to London system
- Offers 24-hour access to NCSCT trained smoking cessation advisors.
- provides user choice of NRT or vape delivered to their home to support their quit attempt.

Mobilisation

Gained agreement to fund from all 33 London boroughs

- Commissioned insights with London smokers into digital smoking cessation support showed strong interest in app to guit smoking.
- Set up steering group of tobacco and smoking leads to support development of service specifications.
- Procurement process to commission provider of digital service.
- SmokeFree app selected as slected supplier.

Implementation

- Year 1 of pilot 2,500 licences pooled across London.
- Soft launch of service November 2024, with full launch including borough promotion of app from January 2025.
- All licences activated by March 2025







Integrated Digital SmokeFree App Pilot

Results

Although formal evaluation of the pilot is still underway initial findings show:

- Licenses activated by residents from every London borough
- App appealed to a broad range of users with use across all age groups and ethnicities
- There was high use of the service out of normal service hours
- Over 50% of users accessing the service between 5pm and 9am
- Over 50% of users lived in the most socioeconomically deprived areas in London (IMDQ1 or IMDQ2)
- 40% of users successfully quit at their 4week follow up
- Only 31% of service users choose to use a service provided stop smoking aid (NRT or Vape)

Challenges

- New commissioning process of health and social care services, Provider Selection Regime (PSR), implemented Jan 2024
- Update of internal processes by procurement and legal teams
- Requirement for in year mobilisation added urgency to the procurement
- Building support from finance teams due to year-on-year agreement for funding
- Rate of uptake of the offer was unknown

Next Steps

- Funding agreed for year two of the pilot from all 33 boroughs
- Licences are now ringfenced to individual boroughs
- Interim evaluation due July 25 and full evaluation due later in the year
- Re-procurement of the digital service now started
- Plan to extend contract to March 2028 (depending on agreed funding)
- Working with NHS London to allow additional funding for further access through primary care channels and targeted football club promotion.

Aims & Objectives

Aim: To mitigate any further widening of inequalities between Black, Asian and Minority Ethnic communities and White British people by leading, supporting, and challenging the London public health system and key stakeholders.

Objectives: To deliver and influence actionable steps, built on five public health recommendations to reverse the disproportionate impact of inequalities through recovery and long-term strategies. The five themes for action development include; trust and cohesion, co-production with communities, improving ethnicity data collection and research, embedding public health in social and economic policy and diversifying the workforce and encouraging systems leadership.



Outcomes for 2024/25

- Pilot organisation for the Race Equity Maturity Index (REMI), a key activity for the London Anti-Racism Collaboration for Health (LARCH). ADPHL/PHTRI supporting the tool's development and evaluation ahead of regional rollout.
- Scoping and Commissioning of Enhanced Anthropology-Based Research (trust, cohesion and social capital workstream).
- Diversifying the workforce and encouraging systems leadership;
 - Completion of 2nd cycle Equality, Diversity, Inclusion and Equity (EDIE) training for public health professionals across LAs, GLA, NHS, and OHID London (June 2024). Expressions of interest from London PH teams and other regions to adapt/localise the training
 - Inclusive coaching pilot delivered to a small cohort of public health professionals. Expansion plans currently in progress.
- Community engagement and insights activities with VCSEs, for the co-production with communities workstream.
- Improving ethnicity data collection; ADPHL/PHTRI and NHS England (North West region) co-led a multi-regional workshop, aimed to foster cross-sector collaboration, identifying system-wide and thematic challenges, and exploring opportunities to align efforts and optimise existing resources (Jan-2025), next phase planning.
- Examples of PHTRI influencing, supporting, and/or complementing borough-level public health work in areas such as anti racism action planning, improving ethnicity data and workforce training and EDI recruitment.

Promoting the use of the REMI across public health, to identify gaps, sense-check and evaluate race equity maturity, incl. a peer-to-peer/service-led practice improvement exercise.

- Co-production; focus on measuring and evaluating co-production.
- Workforce focused; qualitative research, apprenticeships, reverse mentoring and influence in regional workforce EDI spaces e.g. the FPH EDI committee and London Public Health Workforce Collaborative.
- Improving ethnicity data; Influencing London and National data collaborative efforts i.e. through the London Health Equity Data Collaborative, scoping local issues and challenges via DsPH and data analysts and delivering/developing interventions to support the improvement of data quality, collection and disaggregation.
- Embedding public health in social and economic policy; addressing structural racism at a policy and institutional level e.g. linking the Institute of Health Equity (IHE) recommendations on structural racism (Oct,2024) to PHTRI programme objectives, in areas such as (but not limited to) leadership and organisational accountability, insufficient data, research gaps, evaluation, national advocacy and social movement to support anti racism.



Aims & Objectives

Thrive LDN is a citywide public mental health partnership, working towards the shared mission of a city where every individual has equal opportunity for good mental health and wellbeing. We are supported by the Mayor of London and accountable to the London Health Board.



Outcomes for 2024/25

- **Population Mental Health Consortium**
 - The Consortium launched its first year with key events including a Policy Roundtable, a Scientific & Policy Advisory Board chaired by Prof. Kevin Fenton and Clinton Farquharson and an Innovation Lab sandpit with Manchester University focused on the built environment, multiple & complex needs and mental health.
- Climate and Mental Health Action Partnership Endorsed by the Leaders Group in March 24, Thrive LDN launched a Climate & Mental Health Action Partnership addressing the links between climate, nature & mental health. A dedicated pan-London Climate, Environment & Mental Health Action Forum has launched to enable more effective, co-produced and joined-up action on climate, nature and mental health.
- Support for Young Londoners In February 25, <u>findings</u> from a participatory action research project with Toynbee Hall were published, exploring emotional support for young people during the cost-of-living crisis. Young Londoners also participated in the Thriving through Culture evaluation with the Baring Foundation and GLA Culture Team supporting children and young people through arts and creativity.
- **Suicide Prevention** 'Tracking Impact and Attributing Outcomes' paper delivered, recommendations to be enacted in 25/26. Ensure continued alignment with London wide priorities and wider mental health governance.

Crisis Response:

A public mental health response was stepped up in response to the war and violence in Israel and Palestine. In addition, we co-developed a report on supporting the mental health and Wellbeing of Hongkongers in London.

Great Mental Health Day

Thrive LDN facilitated Great Mental Health Day on 31 January 2025 in conjunction with Good Thinking. Over 150 organisations marked the day, more than 45 events took place across London & there were 12,000+ visits to our webpages.through arts and creativity.

Plans for 2025/26

- Public Mental Health Leadership and Mobilisation
 - Delivering year 2 of the Population Mental Health Consortium.
 - Working in partnership with <u>SOAS University to help reshape mental health care in</u> London and globally. This includes an ethnographic pilot on community resilience.
 - Reducing suicide and self-harm in London through real-time data to identify trends and insights on suspected suicides and self-harm.
 - Continuing to deliver and grow the Climate & Mental Health Action Partnership addressing links between climate, nature and mental health.
 - Enhancing crisis response and recovery efforts, including trauma-informed practice training for local authorities and the VCSE sector.
 - Deliver a programme of co-developed projects, supporting Londoners impacted by the cost-of-living crisis.
 - Continuing to support the Mayor's mental health priorities, including supporting the delivery of the Health Inequalities implementation plan.
- Communications and campaigns Pushing for 500k Londoners having completed training through the #ZeroSuicideLDN campaign (currently £450k).
- Impact and Evaluation July 2025: Publish an impact report to ensure transparency and accountability.

Aims & Objectives:

The Community of Practice aims to share knowledge, learn and provide a space to discuss children's mental health at a borough, ICB and pan-London level.



Outcomes for 2024/25

- Quarterly CoP meetings saw a range of key topics including self harm and suicide prevention, research and resilient schools.
- The CoP collaborated with the Public Mental Health Network to host two in-person workshops focused on Suicide Cluster Response Plans and CYP MH suicide prevention.
- In conjunction with University College London (UCL), Mental Health Research For All and the Policy Lab, the CoP held an in-person CYP Collocative Conversation. This had a focus on community centred approaches. The April (2025) event secured high profile speakers from Scotland to level up London.
- Contributed to the NHS 10-year plan in a coordinated approach with UCL
- An extensive CoP review was conducted in January 2025. It sought feedback on CoP effectiveness, efficacy, engagement, usefulness and impact. ASR CoP had second highest response rate out of all ADPHL's Networks and CoPs



Plans for 2025/26

- > Implement feedback from CoP review.
- Develop CYP MH case studies with UCL.
- Establish CYP MH Knowledge Hub (KHub), encouraging use and member engagement.
- Build member connection during and in between meetings through KHub and other methods.
- Conduct member representation analysis. Engagement efforts coordinated based on results to ensure all boroughs and ICBs are represented. Intentional CoP promotion will be undertaken.
- Host CYP MH CoP in-person event.
- CYP MH CoP will be a feature focus in ADPH London's bi-weekly newsletter.

Practice Improvement



Sector-led practice improvement in public health is a collaborative, peer-driven approach to improving the quality, effectiveness, and efficiency of programmes and services, ensuring they meet the needs of the population. It can be delivered through a variety of activities including:

- Sharing of practice and learning
- Peer-to-peer support activities
- Utilising self-assessment tools
- Coordinating work through thematic networks and communities of practice.

In 2024/25 ADPHL explored the <u>Local Government Association (LGA) Strength's and Risks Tool</u> across London, in sub regions and locally. We held peer-to-peer sessions on 'Use of Resources' in particular diversifying the workforce and challenges with the Public Health Grant. The main activity for the year was a partnership workshop with OHID on improving young people's access and engagement with treatment services.







YOUNG PEOPLE'S SUBSTANCE MISUSE


- WORKING TOGETHER PRACTICE IMPROVEMENT FRAMEWORK

1 Context

Substance misuse among young people is shaped by complex factors such as mental health, trauma, poverty, and involvement with the justice system. Vulnerable youth often interact with multiple services, each offering a chance for early intervention. Effective outcomes depend on early engagement, integrated assessments, and joint working, and given the low numbers of young people accessing services across the capital, there is a clear need for better coordinated, multi-agency responses.

2 Scope

Identified as a key practice improvement opportunity, ADPHL have developed a the Young People's Substance Misuse Practice Improvement Framework which aims to improve access to- and engagement insubstance misuse treatment services. It focuses on developing strong partnerships and effective referral pathways into treatment by providing an opportunity to increase the number of young people in services. It is not a formal audit, but rather a mechanism for self-reflection and improvement.



3 Developmental Process

The framework was developed following a <u>London Regional Practice Improvement Event</u> hosted by ADPH London, in partnership with OHID, in the summer of 2024. The conference was attended by commissioners, providers and public health leads, who identified the referral pathways and multi-agency partnerships as an area for improvement. It was reviewed and tested through a series of five sub-regional workshops in the spring of 2025 attended by those core colleagues.



The framework is a series of statements and prompt questions for each theme allowing the user to identify strengths and areas for further development, concluding with an 'Action Plan' to help guide improvement.

5 Use

The framework should be used as part of a local authority practice-improvement exercise to open discussions about current provision, identifying barriers, opportunities, and actions. Local authority commissioners should complete the framework in consultation with providers and other key stakeholders, and critically, the Framework and it's process should be championed by the Director of Public Health. Following initial completion and the identification of actions, it is recommended to review the Framework annually to monitor progress.

Transformation Partners in Health and Care:

Background:

Cardiovascular disease is a leading cause of premature mortality, morbidity and reduced quality of life among Londoners, impacting not only physical health but also mental well-being. However, much of this burden is preventable through effective interventions. Through heart health prevention, and the detection and management of CVD and its risk factors there is significant potential to save lives, enhance overall well-being, tackle health inequalities, and produce broader benefits for local health and care systems and society more widely.

To strengthen this work, London's Health and Care Leaders are collaborating to create a new 5-year London-wide health movement focused on improving heart health awareness, engagement and outcomes.





Promoting heart health awareness



Reducing CVD-related adverse outcomes



Bridging gaps in health equity across the city

This initiative seeks to create a city-wide movement engaging Londoners in improving heart health.

By leveraging evidence-based strategies and community involvement, we aim to amplify the impact of existing programmes and drive collective action.

Through collaboration with diverse stakeholders, including citizens, businesses, and academic institutions, we can foster a culture of prevention and empower individuals to take control of their heart health.



London's Why We Get Vaccinated Campaign

ADPH London is working in partnership with London's public health systems partners: UKHSA London, London Councils and NHSE London to develop the Why We Get Vaccinated community engagement campaign. Launched in October 2024, this is a new three-year, multi-agency behaviour change initiative that has been co-produced with London communities.

The need for this campaign is clear. Vaccination is one of the most cost effective interventions to prevent disease – keeping our communities safe and well, yet vaccination coverage in London remains lower than the national average with notable disparities across different boroughs, certain ethnic groups, and among vulnerable populations, including those in more deprived areas. Additionally, London faces unique challenges such as high population mobility and increasing demand on healthcare services, which further complicate efforts to maintain high vaccination rates.

Why We Get Vaccinated seeks to address these challenges by promoting vaccinations throughout the life course. It aims to build trust and understanding between health partners and the communities they serve by featuring real people including residents, healthcare professionals, and community leaders from across London.

This campaign is a key deliverable of the **London Immunisation Strategy**, and part of the **London Vision** to make London the world's healthiest global city. It provides a consistent, unified message about the importance of vaccinations. It has been designed to provide flexibility so every ICB, local authority, and community group can use it in the way that works best for them. It will complement, not replace, individual vaccination campaigns.

The campaign has been funded thus far by NHS England and UKHSA with funding secured for the evaluation by our partners at the University of Nottingham. Plans are in place for London's DsPH to provide funding for adaptation of the campaign to address local priorities. The campaign team will work with local public health teams in participating boroughs to develop localised assets and implementation plans to reach priority cohorts.




The London Public Health Forum

The London Public Health Forum is led by the Office for Health Improvement and Disparities (OHID) London in partnership with the Faculty of Public Health, ADPH London, UK Health Security Agency, the Greater London Authority (GLA) and NHS England London.

Chaired by Professor Kevin Fenton, these high profile events offer an opportunity to come together as a public health community to discuss strategic, urgent and critical public health issues in our city.

The Forum allows us to collaborate, strengthen networks and share innovative solutions to improve the health of all Londoners and reduce health inequalities.

The Forum is an opportunity to hear from prominent and world-renowned system leaders, speakers and thinkers to discuss how to best tackle key public health challenges in London.



On Wednesday 9 April, the Public Health Forum returned for a deep dive into the issue of tackling racism and ethnic inequalities in London to build health equity.

The session featured Professor Sir Michael Marmot. Director of the UCL Institute of Health Equity as the keynote speaker, following the publication of IHE's report into structural racism in London, presenting a comprehensive review of how structural racism contributes to persistent and avoidable health inequalities among ethnic minority communities in London.

The session also featured an expert panel with Dr Sandra Husbands (DPH Hackney & City and Co Chair of the ADPH London PH-TRI programme), Professor Habib Naqvi MBE, CX NHS Race & Health Observatory, and Jabeer Butt OBECX Race Equality Foundation.

The session included colleagues from the wider NHS as well as health system partners and drew a record attendance of just under 500 attendees.







The London Public Health Forum Presents:

Building Health Equity: Tackling Racism and Ethnic Inequalities in London

Specialist Registration by Portfolio Assessment (SRbPA) Placement Pilot

Background

The SRbPA Route provides a pathway to specialist registration for experienced public health professionals who have not followed the training route. It focuses on retrospective assessment of an individual's knowledge, skills, and experience against the UKPHR's 'Knowledge' and 'Show How' competencies. Some practitioners working towards their Portfolio Pre- Application have reported gaps in their competencies which they are unable to fulfil within their own organisation.

Practitioners agree that a placement may be the only viable option to fill a specific knowledge or skills gap that cannot be addressed within their current role.


Pilot

This 1-year pilot, commencing 1 April 2025, aims to provide candidates with structured opportunities to bridge competency gaps while supporting public health efforts in London.

The London Support Programme has identified candidates who would benefit from the approach. Over the next 12 months this pilot will support 100% of the candidates to complete a hosted placement by liaising with the candidate and host organisation, with 50% in place by 6 months of initial application.

Funding

The placements are an informal, non-funded arrangement; no salary reimbursement is required. Candidates remain employed and paid by their current organisation. The host organisation incurs no financial obligation beyond offering work supervision. The placement is voluntary and informal, not requiring contractual changes.







Governance & Accountablility

The pilot will be overseen by NHSE WTE as part of the existing UKPHR Portfolio Development Programme. The Delivery Partners will provide operational and strategic direction. Progress will be reported formally to the Public Health Workforce Collaborative once a year, and updates provided to ADPH London via the Leadership Team.

Monitoring & Evaluation

NHSE will lead the pilot monitoring uptake, placements and evaluation. The NHSE representative will be in contact with the host organisation at beginning, middle and end of the placement and with candidate halfway through placement. At the end of the placement, participants will be invited to both complete an anonymous survey and to join a group discussion to collect feedback.

NHSE will compile End of Pilot Report including case studies, qualitative and quantitative measures and recommendations for the future of this initiative. The report will be published on the ADPH London website and shared with stakeholders.





The London Sexual Health Programme

The London Sexual Health Programme (LSHP) is a collaborative partnership of 31 London local authorities, hosted by the City of London Corporation, working closely with the NHS to ensure high-quality, accessible sexual health services for all. LSHP is committed to innovation and efficiency, developing sustainable solutions that enhance service delivery, improve access for residents, and support the long-term health and wellbeing of London's diverse communities.

The programme is supported by an ADPH London DPH and CPH Lead for Sexual Health, who provide advice and guidance from a local authority public health perspective. The DPH lead also chairs the LSHP Board.



SEXUAL HEALTH LONDON



The LSHP manage Sexual Health London (SHL.UK), an innovative online service commissioned by 30 London local authorities, designed to provide fast, convenient, and confidential sexual health support. The service is intended for individuals without symptoms of a sexually transmitted infection (STI) or other health needs that require an in-person clinic visit.

In addition to STI testing, 18 London authorities also offer residents access to routine and emergency contraception through the online service.

ADPH London Priorities for 2025/26

Over the next 12 months we will continue to provide DsPH and their teams opportunities to improve public health practice. This includes coordinating our themed networks and communities of practice, ensuring they provide value and impact. We will look at ways to improve member engagement, for example by bringing networks together for special themed meetings such as 'back to school' planning session in August for the CYP and Imms networks. We will also introduce the KHub platform to facilitate sharing of ideas, resources and collaboration within networks and communities of practice.

Other practice improvement activities include the development and roll out of the 'Self Assessment Framework' designed to improve young people's access to and engagement with substance misuse treatment services. We will host an event in collaboration with OHID London to explore the actions identified by local authorities to improve their numbers into treatment. Also this year in partnership with UKHSA, we will bring together London's Health Protection leads for the first time for a practice improvement event to explore the new Health Protection Assurance Framework.

As part of our portfolio of shared pan-London programmes, we will continue to provide assurance and coordinate funding. Following the publication of the 10-year health plan, its emphasis on prevention and prioritisation of cardiovascular disease, we will support the Million Hearts and Minds Challenge initiative to ensure high quality public health input and engagement. Other priorities include the support of the Why We Get Vaccinated campaign, the London Inpatient Detox Programme, and the re-procurement of the Sexual Health London e-services.

To fulfil our commitment to developing the public health workforce, in partnership with the London NHS England Workforce Training and Education Directorate, we will launch and evaluate the pilot for the Public Health Specialist Registration by Portfolio Placement Programme.

Finally will continue building on our strong collaborations across the London public health system, ensuring that DsPH play a part in systems leadership forums. We will strengthen our collective voice in priority areas including active travel, sexual and reproductive health, youth vaping and child poverty.
