Welcome to the North East Gambling-Related Harms programme newsletter. We are working to develop a regional approach to tackle the harm caused by gambling across our region.

As we begin 2025, there is lots of work underway in the North East region to prevent and reduce gambling harms. North Tyneside have a new gambling harm steering group being established. Newcastle, Sunderland, Durham and Hartlepool local authorities are piloting a MECC (Making Every Contact Count) Gambling Harms module. # Public Health Framework for Gambling Harms produced by ADPH Yorkshire and the Humber

The ADPH Yorkshire and the Humber Gambling Harms Programme have recently published a second version of their Public Health Framework for Gambling Harms. This interactive resource covers six topic areas, including: raising awareness of gambling harms, strengthening the evidence base, reducing exposure and access, providing treatment and support, taking a life course and equity led approach and building leadership and capability. ### Participants needed for research

Research is a key part of the <u>ADPH NE Gambling Harms</u>

<u>Programme</u>. One of the current research projects aims to understand Drug and Alcohol workers experiences of gambling related harms (GRH) in treatment settings by:

- Understanding the barriers and enablers to embedding GRH education and support within Drug and Alcohol settings
- Investigating if screening tools and protocols are used to assess and refer patients with GRH in Drug and Alcohol settings
- Determining the type of GRH training Drug and Alcohol staff receive.



The researcher hopes to conduct semi structured interviews with a variety of roles working within a Drug and Alcohol setting. Interview time slots are available across a 15 day period between February and March if you are able to contribute to this work.
