


SLI Snapshot

1. ADPH Sector-Led Improvement Regional Quarterly Report



The latest Quarterly SLI report was submitted to ADPH this April. The report allows networks to build on the information reported from previous quarters and the information submitted can be circulated among networks to encourage sharing of learning and good practice and will be brought as a collective update to the next ADPH SLI Programme meeting in May.

The report included updates on the

- ADPH SW regional behavioural insights programme,
- the proposal of the sexual health PrEP (Pre-exposure prophylaxis) work to improve access to HIV PrEP for underserved populations.
- updates were also provided on the SW ICS CoP with the next workshop being scheduled for late May 2022
- programme updates and plans for Smoking in Pregnancy (Health Visitor Smoke Free Home) and Suicide Prevention were also included.
- we also included our plans for an upcoming CPD workforce development session.

Finally, the report finished with examples of how our network has shared practice with colleagues around the country over the past quarter, our challenges and lessons learnt, our notable impacts and our next steps highlighting expected SLI activity to progress out networks SLI Programme over the upcoming quarter.

2. Shared Intelligence Report

ADPH have commissioned Shared Intelligence to deliver a report on the breadth and variety of Public Health SLI activity, with a particular focus on impact and reflections on progress made over the pandemic. 3. Southwest Health Inequalities Network

As part our of current SLI plan DsPH are currently undertaking a mapping exercise of "SW support and strategic input for Health Inequalities" by each local authority. This mapping exercise covers three elements; Health Inequalities, Inclusive and Sustainable Economies implementation and the newly published Levelling up missions. The exercise will capture areas of focus against the 12 missions of Levelling Up, health inequalities priorities and how LAs are implementing Inclusive and Sustainable Economies frameworks. It will also capture opportunities, challenges, and good practice which we will share across the region.



4. Smoking in Pregnancy → Health Visitor Smoke Free Home SLI Programme



The Smoking in Pregnancy SLI programme is being renamed to Health Visitor Smoke Free Home. This name change is to reflect one of the key proposals of the programme "Improving relapse prevention (during the Maternity Pathway but especially post-partum)". As the programme aims to target the smoking journey past pregnancy looking at the role of the Health Visitor into post-partum the new name reflects this objective more holistically.

5. <u>SLI Vaccine Engagement Programme (VEP)</u>

The VEP network reporting template has been completed and returned to ADPH outlining an overview of key activities that will form part of our VEP plan. The following key activities have been agreed:

- To build on the success of our COVID-19 vaccine uptake to improve reach and uptake in our routine childhood immunisation programmes
- To build on the success of our COVID-19 vaccine uptake to improve reach and uptake in our routine adulthood immunisation programmes, including flu, with specific focus on vulnerable individuals and populations.
- Strengthen the SW COP in relation to vaccination uptake

A case-study vaccine engagement template to support the systematisation of learning and good practice was provided to the SW from ADPH. The template was populated with the following case studies: Primark pop-up, Pop-up in deprived city centre locations, Pop-ups for factory workers, Fisherman outreach, Homeless health pop-up, Secure settings – Screening and Imms support, Developed pack for secure settings – what works to increase uptake, PHE national team developed secure settings-specific comms, Vaccination boat for boating community, LD 'Quiet bus', Inclusion checklist for vaccination sites, Student Clinics, Evaluation of maximising uptake work, Work with Eastern European Catholic population, Using DIIS (linked population health management dataset) for additional intelligence at a local level to track progress in reducing inequalities, Themed sessions at VCs with community ambassadors from ethnic minority groups and the Rapid response outreach team. Case studies are also being collated on the Connect and Exchange Hub.

<u>COVID-19 Vaccine Equalities Connect and Exchange Hub</u> is a community of practices on the Future NHS platform. NHS, local authority, public and voluntary sector staff working to increase vaccine uptake, share ideas, evidence, resources, case studies and blueprints to increase uptake of the COVID19 vaccine within all communities. Members also have access to peer-to-peer support and a programme of regular lunch and learn webinars and live discussion forums.
