


SLI Snapshot

The aim of the Snapshot is to provide a monthly Sector-Led Improvement (SLI) update to DsPH and their public health teams. 1. The Accelerated Access Collaborative's (AAC) Innovation for Healthcare Inequalities Programme (InHIP)

The AAC Board set the direction for an innovation programme that will focus on addressing healthcare inequalities in the five clinical areas outlined in the Core20PLUS5 strategy. This programme will provide national support to enable AHSNs (Academic Health Science Networks) to identify, and support ICSs to scale, evidence-based innovations (including new digital products, devices, diagnostics, or medicines) to help address local ICS healthcare inequalities improvement priorities. The high-level aim of the programme is to enable accelerated access to innovations for people suffering healthcare inequalities across the five clinical areas of focus outlined in the Core20Plus5 approach. The submission deadline for funded project proposals is at 17:00 on 14 October 2022 to: aac.innovation@nhs.net

2. <u>Vaccine Engagement SLI Programme- Network Reporting Template</u>

Background:

ADPH and LGA have received funding from NHSE for a national SLI Programme to support the uptake of the COVID-19 vaccine. Funds have been allocated to each ADPH network to be spent according to regional needs with the objective of supporting vaccine uptake, facilitating the collection of practice and insight and supporting the promotion and implementation of lessons learnt.

Reporting cycle: Written updates are encouraged on a regular basis, and an end of programme report from each network will be requested in December 2022. These will include key achievements against the outlined objectives, insights gained through the process and update on next steps.

Our South West plan of action is to begin a regional bid process for local areas to apply for from the national SLI funding. This will cover both adult and childhood immunisations. We hope the bid process provides the opportunity to help a local area to try out something new in increasing vaccine uptake and engagement and improve health outcomes within the SW. Moreover, new ideas based off lessons learnt from COVID vaccination outreach work are welcomed also. There is potential to use successful case studies of COVID vaccination outreach to see if the same approach can also work for other immunisations programmes. An expectation would be for the bid winners to report back on progress and lessons learnt to bring back wider with other areas in the SW to spread promising practice with others.
