1. DPH Save the date 20th April 2023- SW Marmot Region

Sir Michael Marmot will be coming to South West to attend a conference in person to launch the Southwest as a Marmot Region on the 20 April 2023. The venue and capacity are to be confirmed but the team are aiming for Taunton as the location. Invitation is to South West Directors of Public Health or their teams.

The theme of the day is as follows: SW Marmot Region – Helping accelerate the reduction in Health Inequalities in the South West Region. More information to follow as the programme develops.



2. South West Local Authority Climate and Health Survey

In response to the SW DsPH request for a Sector Led Improvement focus on climate change, South West consultants Sara Gibbs and Caroline Court, OHID colleagues Ishani KarPurkayastha and Dominic Gallagher and SLI Co-Ordinator Jodie Horton compiled a survey to assess where public health teams in the SW are now on this subject and to share good practice.

The survey has been sent to South West DsPH_to identify a senior lead on climate change within their Local Authority Public Health team to complete the <u>South West Local Authority Climate and Health</u> <u>Survey</u> by its closing deadline of the **28**th of February **2023**.

The aims of this survey are to collate the South West's Local Authority Public Health influence, core functions, grant use, engagement and advocacy with external partners on climate change matters. From this we aim to assess the interest for a regional group for climate change leads within PH teams. This will cover both adaptation and mitigation, focusing on getting to net zero, maximising co-benefits to health and reducing inequalities. The group will share good practice and use SLI principles to strengthen PH's role in tacking climate change. Completion of this survey will help to structure the strategy and objectives for Key Objective 5 on the SLI action plan (Climate Change) for the coming year.



3. South West ADPH Microsite and New Logo's

Newly refreshed logos for the South West ADPH Network have been delivered from the ADPH. Please find the new logos at the top left of the first page and within the page footers.

Please note that in contrast to the national ADPH logo, Network logos are only to be used in white, set against the appropriate Network colour and should only ever be used as a full lock-up with the seal. This is so that the Regional Networks can retain ownership of any output without it being confused with national ADPH comms.

The Network colour palettes consist of a lead colour and a supporting, recessive colour. Close attention has been given to ensure that the combination of the colours within a Network achieve a Web Content Accessibility Guidelines (WCAG) 'AA' grading for accessibility. Additionally, white used against any of the lead colours also achieves a WCAG AA Grading.

The colour palette for the South West network, and associated colour codes are displayed below:



The national ADPH website and South West microsite have undergone redevelopment. The South West microsite is still under development as content is pulled across and redesigned, but it is now live and running with the previous content available for use. 4. Covid-19 Public Inquiry Membership Survey: Now Live

Earlier this week, ADPH shared the Covid-19 Public Inquiry Membership Survey with all DsPH across the UK. This survey covers questions regarding pandemic preparedness and planning at a local level and seeks to draw lessons for the future. The survey results, alongside ADPH's written statement, will be crucial in accurately articulating the role of DsPH during Covid-19 and identifying changes that will strengthen the UK's health protection system and pandemic preparedness. Although the link that was shared via email is individual to each DPH, the survey can be completed with other DsPH from your region to submit a joint response if wished. Note that all results will be anonymised by ADPH. ADPH have developed a Word Document version of the survey so DPH are aware of the content and can draft responses before inputting these into the survey online. The deadline for members to complete the survey is 17:00 03 March 2023. ADPH appreciate that this is a short deadline, unfortunately this is because the Inquiry is operating to tight timescales.
