1. South West Extended Network Mapping Exercise

Following the presentation to DPH of the SW Population Health and Wellbeing blended team network mapping exercise, an action was taken to further map regional meetings or networks currently attended, hosted, organised or chaired by members of Local authority Public Health Teams that haven't yet been identified through this first phase of work.

An ask has been emailed out to SW DsPH to nominate a point of contact within their LA PH team to complete a spreadsheet to help identify the missing networks/meetings for this further mapping exercise. In essence this is to have all networks/meetings clearly displayed for PH teams and to identify any network gaps and to avoid any duplication.

The criteria for meetings to be listed includes regional meetings/networks that are attended by DPH or their delegates that hasn't yet been identified within SW Population Health and Wellbeing blended team mapping exercise. We are not looking to collate meetings that are held at a local level only.

Once the spreadsheet has been competed by each South West Local Authority, networks will be mapped and linked under these key groups:

- H&WB boards
- o Public health partnership board
- SW Regional Oversight Group
- o ADPH SW

2. South West Local Authority Climate and Health Survey

The South West Local Authority Climate and Health Survey has now closed, we would like to thank all DsPH and their teams for completing the surveys. We are pleased to have received a 100% response rate from all SW LA's.

The survey will now be analysed to assess interest for a regional group for climate change leads within PH teams. Furthermore, this survey will help to structure the strategy and objectives for Key Objective 5 on the SLI action plan (Behaviour Change: Climate Change) for the coming financial year.

3. <u>Sector Led Improvement Key Objective Phases</u>

As part of the upcoming SW ADPH Network away day a review of the current SLI action plan is due to take place. As part of this review each key objective on the action plan will be categorised under the following phases:

Phase 1

Scoping, Development & Sharing of Good Practise:

- DPH lead identified and key outputs created
- Stocktake/Benchmarking Exercises & Surveys
- Workshop/conference planning
- Self assessments
- Bid processes for funding
- Establishing working groups/Cols
- Guidance development
- Sharing practice between LA's

Phase 2

Local Implementation

- Actioning tangible outcomes from survey results
- Workshops/conferences taking place to inform wider workforces
- Facilitating outcomes & improvements from self assessments
- Bids assigned and projects taking place from funding
- Guidance shared amongst
 South West

Phase 3

Measurable Outcomes and Review

- Quality Improvement achieved for a service
- Improved awareness/understanding of a PH topic for staff/residents
- Lessons learnt & best practise shared from projects (bid winners etc) and implemented into other LA's

Within each ROG (Red, Orange, Green) rated phase there are examples of SLI work undertaken that would be associated with the phase.

Identifying which phase each SLI key objective is currently in will help to aid SLI prioritisation going forward. For example, key objectives currently in phase 2 require time to allow for local implementation to take place before entering phase 3. During this time focus can be put on priorities in phase 1.

It is important to note that:

- Not every SLI Key Objective will reach Phase 3, due to the differing nature of the key outputs DPH's have assigned to each.
- Being in Phase 1 does not mean you are not progressing, being in phase 3 equally does not mean the key objective is complete as further work can be identified if required.
- To note: moving between phase 1>2>3 in the instance of share good practice depends on whether we have had feedback/note of this being implemented as a result of the SLI best practise being shared.

The South West SLI team hope this exercise will be a useful aid to SW DsPH identifying the progress of all SLI key objectives to then determine where to focus attentions moving forward and if there is capacity to develop priorities further.
