



Annual Review 2008-2009

This year was one of consolidation and achievement. Employed staff established systems that ensured regular and useful membership services and continuity across the change in Presidency.

By providing clarity over the role of constituency representatives, adding an extra policy workshop, focusing teleconference agendas and increasing our regular communications and requests for direct input we have improved membership engagement.

Our collaborative projects with voluntary agencies have been focused on priority areas and provide effective models for future use. The aim is to support DsPH locally with useful headline policies as well as advocating for improvements nationally.

Frank Atherton took over from Tim Crayford as President in November and undertook a comprehensive programme of meetings with stakeholders resulting in more collaborative initiatives and clarity around the ADPH purpose and remit. Negotiations have taken place with stakeholders enabling a programme of DPH development within budget starting in 2010.

- Consultation on, development, refinement, piloting and distribution of core-dataset questionnaire which will provide not only useful workforce statistics but a deeper understanding of the membership.
- Discussions with ADASS and ADCS around providing joint development for Directors. Work is continuing following a successful approach to IDeA to support a scoping exercise which will report in July 2009.
- Following ADPH discussions with the National Social Marketing Centre the DH is funding the development of a programme to develop advocacy and influencing skills for DsPH which will be piloted in 2009-2010.
