Prof Mark Petticrew

London School of Hygiene and Tropical Medicine



Mark Petticrew is Professor of Public Health at the London School of Hygiene and Tropical Medicine (LSHTM). He is Director of the NIHR Public Health Policy Research Unit. His main research interests are in evidence-based policymaking, and the evaluation of the effects on health of social and other policies. His work also has a strong focus on the commercial determinants of health – in particular, the influence of unhealthy commodity industries on health (eg through the promotion of tobacco, alcohol, and unhealthy foods). Recent research includes analyses of misinformation disseminated by alcohol industry corporate social responsibility (CSR) bodies such as Drinkaware UK and Drinkwise (Australia). He is

a collaborator in the <u>SPECTRUM Consortium</u>, which investigates the commercial determinants of health and health inequalities. He was a founding member of the Cochrane/Campbell Health Equity Methods Group, which develops methods of incorporating an equity perspective into systematic reviews.

Dr Nason Maani

School of Social and Political Science, University of Edinburgh



Nason Maani holds a Lectureship in Inequalities and Global Health Policy at the University of Edinburgh's Global Health Policy Unit. His research focuses on the commercial determinants of health, with a particular interest in how corporate actors shape discourse and public understanding. He has consulted and served as a member of expert advisory groups for the World Health Organisation (WHO) on this topic, and along with Mark Petticrew and Sandro Galea, is the editor of "The Commercial Determinants of Health", a textbook for Oxford University Press released in October 2022. He retains visiting academic positions at the London School of Hygiene and Tropical Medicine, where he co-founded the Commercial Determinants Research Group, and Boston University School of Public Health, where he completed a Commonwealth Fund

Harkness Fellowship in Healthcare Policy and Practice in 2019-2020.

Daniel Hunt

World Health Organisation



Daniel Hunt is a consultant working on the commercial and economic determinants of health and increasing the political prioritization of noncommunicable diseases (NCDs), at the World Health Organization (WHO). In this role, he is contributing to the first-ever WHO Global Report on the Commercial Determinants of Health, due to be published in 2024, and supporting Member States to design stronger policy responses to mitigate against health externalities caused by economic unhealthy commodity industries. His research interests include explaining and monitoring cross-cutting industry lobbying and influence on public health policy in the UK, EU and globally, and describing efforts by industry actors to socially construct their products as desirable or beneficial. Prior to

working for WHO, he worked for Cancer Research UK and Cancer Council Victoria.

Ailsa Rutter OBE FKC

Director of Fresh and Balance



Ailsa originally trained as a nurse and has worked in tobacco control since 1998. Her early work included heading up the Queensland Quit Campaign in Australia, managing Gateshead and South Tyneside NHS Stop Smoking Service and being Regional Tobacco Policy Manager for the North East. In 2005 Ailsa, working with others, launched Fresh the UK's first regional tobacco control programme and has been its Director ever since. In 2014 Ailsa was awarded a World No Tobacco Day Medal by the World Health Organisation, an OBE in the New Year's Honours 2017 for 'services to tobacco control'. She is passionate about this work, having prematurely lost her father and aunt to COPD. She has also been closely involved in the running of Balance, the North East alcohol

programme launched in 2009, became Director of Fresh and Balance in April 2021, and is proud of the brilliant dedicated small team who work with so many committed partners.

Amanda Healy

Director of Public Health, Durham County Council



Amanda took up the role of Director of Public Health in County Durham in May 2017 having previously been DPH in South Tyneside and is committed to improving and protecting the health of residents. She has worked on reducing health inequalities using an assets approach for over 20 years. County Durham is the lead commissioner for Fresh and Balance Northeast.

Amanda is chair of the North East Association of Directors of Public Health and co-chair of the Integrated Health Board Healthier and Fairer Sub-Committee.

Jo Bibby

Director of Health, Health Foundation



Jo is responsible for leading the Health Foundation's Healthy Lives strategy to create the opportunities for everyone to lead a healthy life. Joining the Foundation in November 2007, Jo initially led the Foundation's influential portfolio of work in patient safety and person-centred care.

Dr Husbands has over 30 years' experience in health care, research and academia in the UK and internationally. She has held a number of senior public health roles at local and regional level, in the NHS, local government and Public Health England.
