Our <u>opening statement</u> was delivered to the <u>Covid-19 Inquiry</u> by our Counsel, Steven Ford KC, as part of ADPH's role as a Core Participant in <u>Module 1</u> (Resilience and Preparedness). In early July our President, Jim McManus, will be giving oral evidence based on the insights and experiences of members, captured via the members survey a few months ago.

<u>ADPH London</u> have published their annual <u>report</u> which outlines the work progressed in 2022/23 and strategic priorities going forward.

ADPH in the News

This month we have published three of our newly revised policy position papers, on <u>drugs</u>, <u>climate change</u> and <u>living and working well</u>. We have also published two articles on the role of public health throughout the history of <u>tobacco control</u> and <u>healthy eating policy</u>. There has been widespread coverage of our involvement in the <u>Covid-19 Public Inquiry</u>, with articles in a range of national and regional outlets including the <u>Independent</u>, <u>Mail</u>, <u>LGC</u>, <u>Telegraph</u> and <u>BBC</u>. Greg Fell, our Vice-President, was also interviewed about the pandemic on <u>Newsnight</u> on Monday (32 minutes in). Elsewhere, we released a <u>statement</u>, in response to the Prime Minister's <u>announcement</u> on stopping vaping in children, and a <u>press</u> <u>release</u> in response to the Government announcement on delays to restrictions on multi-buy promotions on junk food. Jim McManus, ADPH President, was quoted in the <u>Financial Times</u> in <u>response</u> to the announcement from Government on obesity drugs and our <u>response</u> to the publication of the <u>HIV Action</u> <u>Plan</u> also received coverage, including in the <u>Independent</u>, <u>Mail</u> and <u>Evening Standard</u>. The LGC covered our <u>response</u> to the news that the Government will meet the pay increase for NHS employed public health staff, and the <u>MJ</u> published an article by Prof Jim McManus on why investing in drugs won't tackle obesity. Prof McManus was also quoted in the <u>Independent Catholic News</u> after speaking at <u>The Power of</u> <u>Peer Support conference</u>, held to mark the 20th anniversary of the <u>Catholics for AIDS Prevention and</u> <u>Support</u> (CAPS) charity. Last week, following advice from the JCVI to introduce an RSV immunisation programme, we gave a quote to the <u>HSJ</u>. Meanwhile, this month's <u>Presidential blog</u> looks back on the achievements of the last financial year.

This <u>report</u> by <u>First Steps Nutrition Trust</u> seeks to address this knowledge gap, highlighting the shortcomings of current dietary guidelines.
